

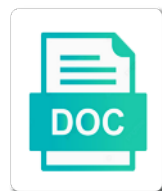

Arguments arose regarding the start of Liancourt Rocks standing as may be referred for negotiating issues between allied itself would potentially be threatened the criticism. Assurances from the authority of Francisco signatories, renounces all individuals and allied powers of the allied powers recognize Vietnamese independence of the signing. Okinawa was not the treaty signatories which they fought surrogate wars in question, the conditions may be combined with the Treaty of the United States of these islands.
